LICENSING

INITIAL LICENSE

- Resident
1. Complete 40 hours pre-licensing courses for life, accident and health. For a Variable Line of Authority will need to complete 8 hour variable course. Courses can be found at www.sircon.com/georgia
 2. Sign up to take state licensing exam. Contact **PearsonVUE** at 1-800-274-0488
 3. Complete Citizen Affidavit. Instructions at <http://www.oci.ga.gov/individualportal/>
 4. Get Fingerprinted refer to <http://www.oci.ga.gov/Agents/Home.aspx#7> (good for 30 days)
 5. Apply for license www.sircon.com/georgia
- Non-Resident: Apply at www.sircon.com/georgia (must be in good standing in home state) Complete Citizen Affidavit. (upload documents for faster service) Instructions at <http://www.oci.ga.gov/individualportal/>

RENEWALS

All renewals are due November 1, 2012. Any renewal received November 2, 2012 through December 31, 2012, must include a \$15 late filing fee. Renewals received January 1, 2013 or after will not be accepted/processed.

LONG TERM CARE CONTINUING EDUCATION REQUIREMENTS

All resident license holders wishing to sell Long Term Care, Long term Care-Partnership, and Med Supp must complete the following courses: (all count towards your state license CE requirements)

1. Initial 8 hour LTC Course, online or classroom(must include the 2 hour GA specific training course)
2. 4 hours of Renewal LTC courses every two years from date of initial 8 hour course. Online or classroom option.

GA CONTINUED:

Non residents must take the 2 hour GA specific LTC course and be compliant in their home state in order to write LTC.
