### INITIAL LICENSE

- Resident

  2. Complete 20 hours of pre-licensing courses for each line of authority (40 hours for Life & Health)
  3. Apply for license at [www.sircon.com](http://www.sircon.com)
  4. Schedule an exam 24 hours after applying for license thru [www.prometric.com](http://www.prometric.com) or 800-871-6457. Prometric will also schedule fingerprinting for you.

Non-Resident: Apply at [www.nipr.com](http://www.nipr.com) (must be in good standing in home state)

***LONG TERM CARE CONTINUING EDUCATION REQUIREMENTS***

All resident license holders wishing to sell Long Term Care, Long term Care-Partnership, and Med Supp must complete the following courses: (all count towards your state license CE requirements)

1. Initial 8 hour LTC partnership Course, online or classroom
2. 4 hours of Renewal LTC courses every two years from date of initial 8 hour course. Online or classroom option.

Non residents must be compliant in their home state in order to write LTC.
